## **Brief overview of the degree programme**

Specialised libraries and cutting-edge IT resources support students’ studies, while internships and labs complete the curriculum, preparing students to respond to contemporary global challenges.

The degree programme includes subjects ranging from the Humanities to Economics, from Management to Communications, and from Design to Information Technology. This disciplinary variety fosters hybrid approaches and provides a wide-ranging understanding of the fashion system, enabling students to move with agility in the global context of the cultural and creative industries.

## **SECTION 1 – ADMISSION REQUIREMENTS**

In order to be admitted to the second-cycle degree programme in Fashion Studies, candidates must:

- a) Have a first-cycle **ACADEMIC QUALIFICATION**, i.e. a three-year university degree or diploma or other suitable qualification earned abroad.

Candidates who have not yet received a first-cycle qualification may also apply. The application procedures are outlined in Section 2 – HOW TO APPLY.

- b) Satisfy the **CURRICULAR REQUIREMENTS** outlined in section 1.1.

- c) Satisfy the **LANGUAGE REQUIREMENTS**, specifically proficiency in English equivalent to at least a B2 level, to be demonstrated according to the procedures set out in section 1.2.

It is also necessary to have an adequate knowledge of the Italian language, according to the procedures set out in section 1.2.

- d) Have their **PERSONAL KNOWLEDGE AND SKILLS** positively assessed in accordance with the procedures set out in section 1.3.

### **1.1- Curricular requirements**

#### **CURRICULAR REQUIREMENTS**

Curricular requirements are verified based on the information provided in the qualification documents and the list of examinations taken.

In order to meet the curricular requirements, candidates must satisfy the degree class requirement (**SECTION A**) and have the number of CFUs required (**SECTION B**).

**SECTION B:** In addition to having received a degree in one of the classes specified, **a minimum of 50 credits** in total must have been earned in the subject areas **falling under at least 2 of the following 5 areas:**

**Arts disciplines:**

ICAR/18 Architectural history; L-ART/03 History of contemporary art; L-ART/04 Museology, art and restoration criticism.

ICAR/13 Design; ICAR/16 Interior design and staging; L-ART/05 Performing arts; L-ART/06; Cinema, photography and television.

**Geographical, historical, sociological and communication disciplines:**

**Economic disciplines:**

Any curricular additions in terms of CFUs may be earned by passing individual exams in the subject areas listed above. The documentation proving these CFUs have been earned must be submitted in accordance with the deadlines and procedures set out each year for the submission of applications to the master's degree programme:

## 1.2- Language requirements

Admission to the programme is subject to proving one’s English language skills, equivalent to level B2 (or higher) of the Common European Framework (CEFR).

Language proficiency tests (“Idoneità linguistiche”) and study plan exams will not be considered for the English language proficiency requirement.

The English language proficiency requirement is met even in the absence of one of the certificates listed in the table for candidates who have (or are in the process of earning):

- A university degree taught in English.
- A university degree in English Language and Literature (or equivalent).<sup>2</sup>

These candidates are in any case required to submit a document in which one of the aforementioned conditions is clearly stated (e.g. in the case of degrees taught in English, a document issued by the university that awarded the degree, stating that the language used for teaching was English).

### **Knowledge of the Italian Language**

To enter the programme, in addition to a B2 level knowledge of English it is necessary to have an adequate knowledge of the Italian language.

Foreign students who do not meet this requirement will have to include learning activities aimed at achieving an adequate knowledge of the Italian language in their study plan.

Full information on how to fulfil the requirement will be published on the degree programme’s website.

### **1.3- Assessment of personal knowledge and skills**

The admission of candidates satisfying the curricular and language requirements as assessed in the previous phase of the admissions process (Art. 1.1 and 1.2) is subject to verification of their personal preparation by an admissions board.

This verification will take place through the attribution of a maximum score of **100 points** to the candidates’ academic background and experience in fashion, according to the following criteria:

- b. Graduation mark (for graduates) or weighted grade point average (for near-graduates). **Up to 50 points**, awarded according to the following criteria:

Any decimal points obtained will be rounded up if greater than or equal to 0.5 or will be rounded down if less than 0.5.

- c. Academic experience in addition to the first-cycle degree (including professional Master's degrees, specialisation schools, etc.) or extracurricular experience (work or volunteering, other activities as judged by the admissions boards) in the field of Fashion: **up to 15 points**.

For each experience related to Fashion (as per the previous paragraph) lasting at least three months, and indicated in the candidate's Curriculum Vitae, 5 points will be awarded.

Candidates scoring **65 points** or more will be **admitted** to the degree programme.

Candidates scoring **between 50 and 64 points** will be invited to an online **integrative interview**<sup>3</sup> by the designated admissions board, aimed at ascertaining their knowledge and skills in the field of Fashion, after which the board will express a judgement of eligibility or non-eligibility. **Candidates deemed eligible following the interview will be admitted to the degree programme.**

Candidates scoring **49 points** or less and candidates deemed ineligible following the interview **will not be admitted** to the degree programme.

## SECTION 2 – HOW TO APPLY

Applications must be submitted by the deadline for each Intake, in accordance with the following procedure.

1. **Log onto** Studenti OnLine ([www.studenti.unibo.it](http://www.studenti.unibo.it)) using your SPID username and password. The system will automatically retrieve your personal details and it will create your university credentials ([nome.cognome@studio.unibo.it](mailto:nome.cognome@studio.unibo.it)).

International students who do not have an ID document issued in Italy, and who therefore cannot obtain SPID credentials, may log in with their university username and password which can be obtained by going to [www.studenti.unibo.it](http://www.studenti.unibo.it) and clicking on *Register* and then *International students registration*.

2. **Click on** "APPLY FOR ADMISSION", select "SECOND-CYCLE DEGREE" and choose the programme named "FASHION STUDIES";
3. **UPLOAD** the required documents in PDF format:

The admissions board will only assess documents uploaded through the online application. Any mandatory documents that are missing or only partially uploaded by the application deadline shall result in the candidate not being selected for admission.

Documents must not be sent by post or email to administrative offices.

Students who are about to graduate can also apply. They will be admitted to the degree programme on the condition that they earn their undergraduate degree by and no later than the date established by the Academic Bodies. Candidates who do not meet this requirement will be excluded.

All professors in charge of teachings of the degree programme may also sit on the admissions boards as alternates.

Candidates will be notified about admission to the degree programme via Studenti OnLine ([www.studenti.unibo.it](http://www.studenti.unibo.it)) and via their institutional email (example: name.surname@studio.unibo.it), starting from the date indicated in step 4 for each Intake in the general calendar.

Those who do not pass the assessment of the personal knowledge and skills at one Intake may not participate in the subsequent Intakes of the same academic year, as set out in the general calendar on p. 3 of the call for applications.

## SECTION 4 – ENROLMENT

If you are admitted to the degree programme, you will be able to enrol starting from the date indicated under step 5 in the above intake calendar. To enrol, you must complete the following steps.

1. **Log on** to Studenti OnLine ([www.studenti.unibo.it](http://www.studenti.unibo.it)) entering the username and password obtained when submitting your application.
2. **Select "Enrolment"**, then select “Second-cycle Degree”, and then the degree programme “**FASHION STUDIES**” and enter the required data, attaching a jpg file containing a passport-size photo of your face. In case you made false statements you will incur in fines set by art. 496 of the Penal Code and you will automatically lose the right to enrol and will not be entitled to any financial aid (when obtained). You will not be refunded of the expenses you sustained.
3. **Pay the first instalment** following the instructions provided on Studenti Online ([www.studenti.unibo.it](http://www.studenti.unibo.it)).

After paying the enrolment fee, check the details of your enrolment application on Studenti OnLine ([www.studenti.unibo.it](http://www.studenti.unibo.it)) to verify your next steps and activate your career.

Your University career must be activated by the deadline set on a yearly basis by the Academic Bodies, otherwise your enrolment will be cancelled.

### 4.1 - Special cases

- **If you have a conditional offer**, you must obtain your undergraduate degree no later than the date set by the Academic Bodies.

If you are a University of Bologna graduate, the IT system will automatically update the data concerning graduation after you obtain the qualification.

If you are graduating from a different institution, check your next steps on Studenti OnLine ([www.studenti.unibo.it](http://www.studenti.unibo.it)).

- **If you hold a certificate demonstrating recognised invalidity of at least 66% or a certificate complying with Law 104/92**, in order to benefit from the exemption detailed at <https://www.unibo.it/en/study/study-grants-and-subsidies/exemptions-and-incentives/exemptions-for-disabled-students>, upon enrolment you should send the certificate via email to the [Student Administration Office of the Campus of Rimini](#).
- **If you are a non-EU citizen with EU-equivalent status and you have obtained your qualification in Italy** you must provide the [International Desk of the Campus of Rimini](#) with a copy of your residence permit which confirms the EU-equivalent status.
- **If you hold an international qualification**, after completing the above steps check the [required documentation](#) to enrol.
