### **SECTION 1 – ADMISSION REQUIREMENTS**

In order to be admitted to the second-cycle degree programme in ECONOMICS AND PUBLIC POLICY, Curriculum in HEALTH ECONOMICS, MANAGEMENT AND POLICY (HEMAP) candidates must:

- a) hold a first-cycle **ACADEMIC QUALIFICATION**, i.e., a three-year University degree or diploma or other suitable qualification obtained abroad. Candidates who have not yet obtained a first-cycle qualification may also apply. The application procedures are outlined in Section 2 HOW TO APPLY;
- b) fulfilment of the CURRICULAR REQUIREMENTS outlined in section 1.1;
- a) meet the **LANGUAGE REQUIREMENTS** and, specifically, proficiency in English equivalent to at least B2 level, to be demonstrated according to the procedures set out in section 1.1;
- b) have their **PERSONAL KNOWLEDGE AND SKILLS** positively assessed in accordance with the procedures set out in section 1.2.

# 1.1- Curricular and language requirements

#### **CURRICULAR REQUIREMENTS**

To be admitted it is necessary to hold an Italian undergraduate degree in one of the following disciplinary areas, or a suitable foreign qualification according to the Italian law:

Candidates who have not yet obtained the qualification required for admission may also register for the selection test. Candidates who pass the selection test will be able to enroll *sub condicione*; if they do not obtain their degree within the deadline established annually by the University bodies, enrollment will be automatically cancelled.

Students enrolled *sub condicione* will have their career suspended, therefore they will not be able to use the Studenti Online application (study plan, exam booking...) until the certificate attesting the achievement of the degree has been sent.

#### LANGUAGE REQUIREMENTS

Admission to the programme is subject to possession of English language skills to at least Common European Framework (CEFR) level B2.

The English language requirement may be satisfied through:

- 1. submission of a suitable certificate. Recognised certificates are listed at page 7;
- 2. holding a first or second cycle degree in entirely attended in English;
- 3. having passed an English test at B2 level during your university studies (level must be specified into the name and/or the programme of the teaching which must be enclosed);

4. to be mother tongue: Italian or foreign citizen which can speak naturally and fluently in English (enclose self-statement).

# 1.2- Assessment of personal knowledge and skills

In addition to the above-mentioned requirements, the admission to **Health Economics, Management** and **Policy** is conditional on the assessment of the personal qualification by the Admission Board according to the following criteria:

- academic merit (it refers to the duration and quality of degree course attended): max 70 points;
- 2. coherence between the academic curriculum and the learning objectives of the Master in Health Economics, Management and Policy: max **30 points**;

Only students who reach a minimum of **60/100** points will be considered as holding a sufficient personal qualification.

#### **SECTION 2 – HOW TO APPLY**

Applications must be submitted within the timeframe set by each intake in accordance with the following procedure.

- 1. Log onto Studenti OnLine (www.studenti.unibo.it), using your SPID username and password. The system will automatically retrieve your personal details and it will create your University credentials (nome.cognome@studio.unibo.it).
  International students who do not have an ID document issued in Italy and, therefore, cannot obtain SPID credentials, may log in with their University username and password which can be obtained by going to www.studenti.unibo.it and clicking on Register and then International students registration
  - 1. Click on "APPLY FOR ADMISSION", select "SECOND-CYCLE DEGREE" and choose the programme named "ECONOMICS AND PUBLIC POLICY CURRICULUM HEALTH ECONOMICS, MANAGEMENT AND POLICY" "
- 2. UPLOAD the required documents in PDF format:

#### MANDATORY DOCUMENTS

- a copy of the front and back of a valid identity document. If the identity document does
  not have an English translation, a copy of your passport must be attached;
- curriculum vitae in English;
- Self-certification regarding your first-level academic qualification with a list of the exams
  taken, if obtained in Italy, or a copy of the qualification obtained abroad which enables
  access to second-level degree programmes in the country in which it was obtained,
  accompanied by a Transcript of Records and a Diploma Supplement, where available,
  translated into Italian or English. If you have not yet obtained the aforementioned
  qualification, upload the list of exams taken or the Transcript of Records.
- Statement of Purpose
- For non-native speakers of English, a certificate of English proficiency among the following:
  - ✓ TOEFL, IELTS, CAMBRIDGE English Language Assessment, Trinity College London.

  - ✓ Certificates need to be no older than 3 years from the issuing date.

#### **OPTIONAL DOCUMENTS**

- any additional documentation certifying educational activities or competencies acquired by the candidate: Graduate Record Examination (GRE) certificate, Summer Schools attendance, specialisation courses...
- for NON-EU citizens: a copy of valid permit of stay, in case candidates already have it;

The Admission Board will only assess documents uploaded through the online application. Any mandatory documents that are missing or only partially uploaded by the application deadline shall result in the candidate not being considered (or selected) for admission.

Documents must not be sent by post or e-mail to administrative offices.

Students who are about to graduate can also apply. They will be admitted to the degree programme on the condition that they obtain their undergraduate degree by and no later than the date established by the Academic Bodies. Candidates who do not meet this requirement will be excluded.

#### **SECTION 3 – ADMISSION**

An Admission Board will check candidates' academic backgrounds and whether they meet the requirements for admission.

The Admission Board is composed of: **Matteo Lippi Bruni** (Chairman), **Pietro Biroli** (Member) **Denni Tommasi** (Secretary). Professors delivering classes in the first year of the degree programme may also sit on the committee as alternative members.

Candidates will be notified about admission to the degree programme via Studenti Online (<a href="mailto:www.studenti.unibo.it">www.studenti.unibo.it</a>) and on your Unibo e-mail (exemple: <a href="mailto:name.surname@studio.unibo.it">name.surname@studio.unibo.it</a>), starting from the date indicated under step 3 in the above intake calendar. Candidates that are not admitted may apply for other intakes.

# 3.1 Grants for students enrolling in the Academic Year 2023/24.

In order to incentivize the enrolment of students, the Department of Economics will award 3 grants, distributed as follows:

- ✓ 2 grants for the first intake.
- ✓ 1 grant for the second intake.

Each scholarship amounts to € 4608 gross of taxes. The scholarship is granted for one academic year. Grants that are not assigned in one intake will be assigned in the following intakes. Grants that are not assigned after all intakes have taken place, will be assigned in the following academic year.

#### Eligibility

Grants are reserved to students enrolling in the Laurea Magistrale in **ECONOMICS AND PUBLIC POLICY - CURRICULUM HEALTH ECONOMICS, MANAGEMENT AND POLICY** for the A.Y. 2023/2024 and that have been admitted with a minimum score of **65/100 points**.

#### **SECTION 4 – ENROLMENT**

If you are admitted to the degree programme, you will be able to enrol starting from the date indicated under step 4 in the above intake calendar. To enrol, you should complete the following steps.

- 1. **Log on** to Studenti OnLine (<u>www.studenti.unibo.it</u>) entering the username and password obtained when submitting your application.
- 2. Select "enrolment", then select "Second-cycle Degree", and then the degree programme named ECONOMICS AND PUBLIC POLICY CURRICULUM HEALTH ECONOMICS, MANAGEMENT AND POLICY and enter the required data, attaching a jpg file containing a passport-size photo of your face. In case you made false statements you will incur in fines set by art. 496 of the Penal Code and you will automatically lose the right to enrol and will not be entitled to any financial aid (when obtained). You will not be refunded of the expenses you sustained.
- 3. **Pay the first instalment** following the instructions provided on Studenti Online (<a href="https://www.studenti.unibo.it">www.studenti.unibo.it</a>).

After paying the enrolment fee, check the details of your enrolment application on Studenti OnLine (<a href="https://www.studenti.unibo.it">www.studenti.unibo.it</a>) to verify your next steps and activate your career.

Your University career must be activated by **February 29<sup>th</sup> 2024**, otherwise your enrolment will be cancelled.

#### 4.1 - Particular cases

- If you have a conditional offer, you must obtain your undergraduate degree no later than the date set by the Academic Bodies: for the a.y. 2023/2024 the deadline is February 29<sup>th</sup> 2024.
  - If you are a University of Bologna graduate, the IT system will automatically update the data concerning graduation after you obtain the qualification.
  - If you are graduating from a different institution, check your next steps on Studenti OnLine (<a href="https://www.studenti.unibo.it">www.studenti.unibo.it</a>).
- If you hold a certificate demonstrating recognised invalidity of at least 66% or a certificate complying with Law 104/92, in order to benefit from the exemption detailed at

<u>www.unibo.it/it/servizi-e-opportunita/borse-di-studio-e-agevolazioni/esoneri-e-incentivi/esenzioni-per-studenti-portatori-di-handicap</u>, upon enrolment you should send the certificate via e-mail to the relevant <u>Student Administration Office</u>.

- If you are a non-EU citizen with EU-equivalent status and you have obtained your qualification in Italy you must provide a copy of your residence permit which confirms the EU-equivalent status at segecosta@unibo.it.

The documentation which you submitted for admission to the degree programme (e.g. diploma, transcript of records...) must be <u>translated and bear proof of authenticity when</u> applicable.

You will need to upload the documents concerning your international qualification on Studenti OnLine (<a href="www.studenti.unibo.it">www.studenti.unibo.it</a>) in the section "Calls" by selecting ""Matriculation for the 23\_24 academic year - document upload for international students with foreign qualifications".

When you arrive at the University of Bologna, you must make an appointment with the International Student Administration Office in Bologna (internationaldesk@unibo.it) in order to show the original copies of your documentation.
