

Call for applications for mobility scholarships at the Royal University of Law and Economics (Cambodia)

DEADLINE: January 15, 2024 1:00 p.m.

ARTICLE 1 - NUMBER AND AMOUNT OF SCHOLARSHIPS

A competition is announced for the award of No. 3 Mobility Scholarships to the Royal University of Law and Economics (RULE) in Cambodia reserved for students of the Master's Degree Programme in Law, Economics and Governance (LEGo).

3 scholarships are available for a total amount of €6,000. The amount of each scholarship is €2,000 gross institution.

The winners of the scholarships will be able to attend courses offered by RULE during the period from March 1 to July 31, 2024. A minimum stay of 4 weeks and a maximum stay of 10 weeks is authorised. The scholarship amount does not vary according to the length of stay.

Scholarships are intended as partial financial aid for expenses related to study abroad. The scholarship recipient, by virtue of existing agreements, will not have to pay any tuition fees at the partner institution. Visa, travel, insurance, board and lodging costs are the responsibility of the recipient.

From the proficiency exams taken at RULE, recognition may be sought at the University of Bologna.

If the student does not carry out the stay abroad in the planned period and if at the partner university he/she does not pass congruous activities to obtain the recognition at UNIBO of at least 4 (four) CFUs, the scholarship must be returned. Where impediments to the regular use of the scholarship (e.g. maternity, serious and documented illness, etc.) occur after the submission of the application, the person concerned will still retain the right to the scholarship, which will therefore be temporarily deferred and from which he/she will be able to benefit once the specific impediment has ended.

ARTICLE 2 - REQUIREMENTS FOR PARTICIPATION

To participate in the competition, applicants must be regularly enrolled for the academic year 2023-2024 in the first year of the Master's Degree Programme in Law, Economics and Governance.

ARTICLE 3 - SUBMISSION OF APPLICATIONS

The application for participation in the competition may be submitted no later than January 15, 2024, 1:00 p.m.

Applicants must submit, under penalty of exclusion, the following documents to the relevant fields on StudentiOnline:

- curriculum vitae
- photocopy of ID.

ART. 5 - SELECTION PROCEDURE AND RANKING LIST

The evaluation of the applications will be carried out by a Commission composed as follows: Prof. Maria Rita Tagliaventi (President), Prof. Marianita Gioia (Secretary), Prof. Massimiliano Musi (component) and all the LEO professors (alternate members).

The rankings will be formulated in descending order of total score assigned to each student and given by the sum of the following partial scores:

Number of exams passed, number of credits earned, candidate's weighted average as of the announcement deadline Max points 20
Curriculum vitae Max points 20
Score obtained in the rankings for admission to the Master's Degree Programme in Law, Economics and Governance in the academic year 2023/24 Max points 20
Motivational interview Max points 40
TOTAL Points 100

Overall evaluation will be in hundredths with eligibility threshold set at 50/100.

In case of a tie in total score, the younger age will prevail.

The ranking list for awarding scholarships is approved by Decree of the Director of the Department of Sociology and Economic Law and will be published within 15 days after the deadline of this announcement in the same manner as this announcement.

ARTICLE 6 - ACCEPTANCE

The communication regarding the winning of the scholarship will be made by sending an e-mail to the institutional e-mail address (@studio.unibo.it).

The winner must send to didatticasociale.lego@unibo.it, under penalty of forfeiture, a declaration of acceptance of the same grant under the conditions of the call for applications within 3 working days of receipt of the aforementioned e-mail, in the manner indicated therein.

At the end of the mobility, the student must send to didatticasociale.lego@unibo.it a period certificate certifying the actual completion of the mobility.

ARTICLE 7 - INSURANCE

The Decree of the Director of the Department of Sociology and Economic Law constitutes formal authorization to ensure the insurance coverage of the assignees in the travel and stay. In general, if the assignee is a student, the insurance coverage will operate automatically as long as the assignee is duly enrolled.

ARTICLE 8 - INCOMPATIBILITIES

The general principles, defined by the Academic Bodies (Board of Directors of 26/07/2016, Academic Senate of 19/07/2016, Student Council of 16/07/2016), on the subject of incompatibility in the context of international mobility apply to these scholarships. They stipulate that one cannot benefit, in relation to the same period of mobility, from more than one grant.

ART.9 - PROCESSING OF PERSONAL DATA (art.13 EU Regulation 2016/679).

Personal data provided with applications to participate in the call will be processed in compliance with the provisions of Regulation (EU) 2016/679 (General Regulation on the Protection of Personal Data) and Legislative Decree no. 196, s.m.i. of 30 June 2003 (Code on the Protection of Personal Data).
