## **Call for applications for grants to support student's participation to Scientific Congresses.**

**RESERVED FOR REGISTERED STUDENTS AT EMJMD ERASMUS MUNDUS WOP-P - ACADEMIC YEAR 2017/2018.**

### **ART. 1 - TYPES OF GRANTS, AMOUNTS AND PAYEES**

The Vice Presidency of the "Scuola di Psicologia e Scienze della Formazione dell'Alma Mater Studiorum - Università di Bologna" calls for applications for grants to support student's participation to scientific congresses in Psychology.

The grants are reserved for registered students at EMJMD Erasmus Mundus WOP-P in Academic Year 2017/2018.

The Evaluating Committee will assign a whole amount of € 2.600,00.

The amount of each single grant will be determined by the Evaluating Committee depending on the characteristics of the congress chosen by the applicant.

The list of congresses among which applicants can choose (ONLY ONE CHOICE) is the following:

PARTICIPATION FEE: Euro 366 - **Maximum** assignable grant for this congress will be €500.

PARTICIPATION FEE: Euro 80 - **Maximum** assignable grant for this congress will be €250.

PARTICIPATION FEE: FREE - **Maximum** assignable grant for this congress will be €80.

### **ART. 2 - ADMISSION CRITERIA**

None, all applicants, registered students at EMJMD Erasmus Mundus WOP-P - Academic Year 2017/2018, will be eligible.

### **ART. 3 - EVALUATION PROCEDURES**

The Evaluating Committee, composed by *Professors Luca Pietrantonì, Rita Chiesa and Dr. Sergio Sangiorgi*, will publish results by June 2<sup>nd</sup> 2018.

### **ART. 4 - APPLICATION**

The subject of the application e-mail must be: "APPLICATION TO GRANT FOR ATTENDANCE CONGRESS – YOUR NAME AND SURNAME AND ACRONYM OF THE CONFERENCE".

Application forms must be delivered by **May 31st 2018 H 24:00**. Applications not delivered by the mentioned deadline will not be considered.

### **ART. 6 - PUBLICATION OF RESULTS**

Granted students will be informed by e-mail. The list of granted students will be published on Course's website <http://corsi.unibo.it/2Cycle/OrganizationalPsychology/Pages/default.aspx>

Winners must inform the course's coordinator about their acceptance of the grant. In case of resignations the funds will be assigned to other applicants.

### **ART. 7 - PAYMENTS**

**Assigned amounts will be transferred to winners by September 30th 2018.**

After the congress, winners will send the attendance certificate to the congress AND a brief report about congress' themes of, at least, 5000 characters. The report has to be sent using the same e-mailbox used for application procedure (see art.5). Not sending the report will prevent winners from receiving the grant.

### **ART. 8 - PERSONAL DATA**

All personal data requested for application will be treated only for the purpose of managing this competition procedure (Italian Privacy code Art. 13 del D.Lgs. 196/2003 (Codice in materia di protezione dei dati personali))
