CALL FOR APPLICATIONS FOR SCHOLARSHIPS SUPPORTING STUDENT'S PARTICIPATION
IN CONGRESSES OR CONFERENCES (NATIONAL OR INTERNATIONAL)
RESERVED FOR STUDENTS ENROLLED IN
PSYCHOLOGY OF WELLBEING AND SOCIAL INCLUSIVITY MASTER'S DEGREE COURSE

ART. 1 - TYPES OF SCHOLARSHIPS, AMOUNT AND RECIPIENTS

The Department of Psychology announces a competition for the provision of scholarships, reserved for students enrolled in Psychology of Wellbeing and Social Inclusivity Master's Degree, to encourage participation in national or international congresses or conferences in the field of "Psychology of Wellbeing and Social Inclusivity".

The Selection Committee will assign a total amount of €1,700.00. The assignment of individual contributions will be determined by the Commission itself on the basis of the characteristics of the event chosen in the application.

It is possible to apply to participate in only one of the following congresses or conferences:

ART. 2 - AWARDING CRITERIA

The criteria for awarding the scholarships will be:

- 1) number of credits earned up to the application deadline;
- 2) number of passed exams;
- 3) grade point average.

ART. 3 - EVALUATION OF APPLICATIONS: METHODS AND TIMES

The evaluation commission will be composed of *Prof. Rabih Chattat, Prof. Cinzia Albanesi, Dr. Giacomo Valducci* (substitutes *Prof. Rita Chiesa, Prof. Monica Rubini*). The results of the evaluation of the applications will be published on the course's website within 15 days of the call deadline.

ART. 4 - INCOMPATIBILITY

The contribution is incompatible and cannot be combined with other scholarships received for the same purpose in the same year.

ART. 5 - APPLICATION

The application for participation in the competition, filling in the specific form, must be received by Friday 31 March 2023 at the UOS Department of Cesena - Piazza Aldo Moro, 90 - 47521 Cesena. The application form must be sent:

- by e-mail to giacomo.valducci@unibo.it (with subject: *Call for conferences Master's Degree Work, Organizational and Personnel Psychology 2023*).

The following documents must be attached to the application:

- resident or non-resident fellows form (to be completed in every part);
- photocopy of a valid personal identity document;
- certification of the exams taken (to be printed via [Studenti Online](#)).

The Department reserves the right to carry out checks on the truthfulness of what has been declared. Without prejudice to the penal sanctions provided for by the D.P.R. 445/2000, if the untruthfulness of the content of the declaration emerges from the check, the declarant loses the right to benefit from the scholarship in question.

ART. 6 - NOMINATION OF WINNERS

The names of the winners will be published on the course website. The scholarship will be paid before departure for the chosen destination.

The winners, under penalty of reimbursement of the total amount of the scholarship, must send an email to the Secretariat of the UOS sopra di Cesena (giacomo.valducci@unibo.it), within 2 weeks of returning from the event, the certificate of participation, which will be issued by the Secretariat that manages the event, and a detailed report to the Course Coordinator (monica.rubini@unibo.it) on participation in the congress/conference.

Art. 7 - RENOUNCEMENT OF SCHOLARSHIPS

In case of renunciation, the scholarships will be assigned to any equal merit applicant or to the suitable ones in the ranking list.

ART. 8 – PERSONAL DATA

Personal data transmitted by participating in the competition will be processed solely for the purposes of managing the competition procedure and in compliance with the provisions of Legislative Decree 196/2003 (Code regarding the protection of personal data) and subsequent modifications.
