**N. 3 scholarships for graduates of the degree programme in

ART. 1 – Subject and amount

The University of Bologna has granted **n. 3 scholarships** for graduates in due time for the academic year 2016/2017, for the amount of € **1.500,00** (before tax) for the first in the ranking list and of € **1.000,00** (before tax) for the second and third in the ranking list.

ART. 2 – Eligible Candidates

Graduates of the second cycle degree program (Laurea Magistrale) in Tourism Economics and Management meeting the following requirements:

- to be first enrolled in the academic year 2015/2016 in the above mentioned second cycle degree programme;
- to graduate within 31 March 2018;
- minimum final grade 110/110.

ART. 3 – Evaluation criteria

The grants will be assigned by the following Committee members:

Lorenzo Zirulia, Francesco Maria Barbini and Maurizio Mussoni.

The evaluation will be based exclusively on merit requirements:

- Evaluation of the final thesis (max 15 pt)
- Final grade:
 - 110/110 = 3 pt
 - 110/110L = 5 pt

Minimum score: 15/20

In the event of equal score, the benefit will be granted to the youngest applicant.

ART. 4 – Payment

The grants will be paid in a single instalment by the central Administration of the University of Bologna, upon notification of final results.

ART. 5 – Compatibility

The grant is compatible with other scholarships or grants.

The application form shall specify:

- 1) Name and last name, birthdate and birthplace, residency and fiscal code;
- 2) Degree Self-certificate with date and final grade;
- 3) Not to have pendent disciplinary sanctions;
- 4) Updated address and tel. number where to receive notifications.

Documents to be attached:

- a) copy of the final thesis in digital format;
- b) copy of a valid ID.
 - Italian and EU citizens can provide self-certification of professional and academic qualifications, according to art. 46 e 47 del DPR 445/2000.
 - NON EU citizens must conform to art. 3.2 and 3.3 of the DPR/2000.

The personal data provided shall be processed in compliance with the principles, and provisions of Italian Legislative Decree no. 196/2003 (Data Protection Act) and in any case exclusively for the purposes of this call for applications. The Administration reserves the right to verify the truth of the information provided. Without prejudice to the penal sanctions laid down in article 76 of Italian Decree of the President of the Republic no. 445/2000, in the event of fraudulent information being discovered as result of such verification, the applicant will forfeit the right to the benefit.

ART. 7 – Assignment

The grants will be assigned according to art. 4 above.

ART. 8 - Acceptance

Selected candidates shall confirm their acceptance of the grant within 10 days from official notification, sending declaration of acceptance duly signed, or the assignment shall be invalid.
