

Call for applications for 3 scholarships for the best thesis (final dissertation) addressed to the students/graduates of the Rimini Campus of the University of Bologna

(Abstract of the Call for Applications in English language)

N.B.: The Italian language version of the Call for Applications is prevailing with regard to the exact interpretation of the rules contained within, also in case of potential disputes.

“Studi Skema Dottori Commercialisti” together with “Uni.Rimini S.p.A.” offers 3 scholarships (EUR 1,500.00 for the first place, EUR 1,000.00 for the second place, and EUR 500.00 for the third place, before taxes) addressed to the students/graduates of Rimini Campus of the University of Bologna, who wrote the best thesis about “The economic and financial system with useful implications for the development of the companies and the territory of Rimini”.

Candidates must apply within **October 30th, 2019 at 12.00 (Noon – Italian Time)**.

Eligible applicants are the students who have graduated since November 21st, 2018 at one of the degree courses of the Rimini Campus of University of Bologna (Bachelor’s or Master’s degree) and graduating students who will graduate within the deadline of this call for applications (October 30th, 2019).

Calendar:

- Application Deadline: October 30th, 2019 at 12.00 (Noon – Italian Time);
- The list of eligible candidates and the dates for the interviews will be out on November 6th 2019 (for international candidates, interviews will be in English language);
- End of the interviews: November 20th, 2019;
- Successful candidates will be informed via email within November 25th, 2019.
- The prizes will be awarded during the event “Premio Cultura d’Impresa 2019” (to be scheduled possibly on mid December 2019).

Candidates will be evaluated on the basis of the topic of their dissertation (i.e. coherence with the topic of this call for applications) and their final mark.

Candidates must apply using the annex to the call for applications (annex and call both available only in Italian language) and attach the following documents:

- 1) Self-certification of the graduation degree with final mark, a copy of the thesis’ title page, and a summary of the thesis (max. 1800 characters – 30 lines for 60 characters). For candidates who did not graduate yet when applying, they can hand out the title page and the self-certification of the final mark no later than the deadline of the call for applications: October 30th, 2019;
- 2) Copy of candidate’s ID;
- 3) Copy of candidate’s “Italian Tax Payer’s Number” (Codice Fiscale).

In case of renounce/withdrawal of the candidate ranked as a winner, the prize will be awarded to the next eligible candidate available.
