- the 1<sup>st</sup> year at ICN Business School (60 ECTS credits)
- at least 45 ECTS at the University of Bologna (excluding the final dissertation);
- after completing the final dissertation at ICN Business School (15 ECTS) they will obtain ICN final degree and they can send their final transcript and diploma to the University of Bologna in order to obtain the double degree.
