

Advanced training on managerial challenges in international business contexts.

It develops entrepreneurial skills related to innovation and the creation of new businesses, with an interdisciplinary approach that integrates economic, business, statistical and legal knowledge.



## **ECONOMIA E COMMERCIO**

Specialised training for professionals with legal, accounting and managerial skills to provide consulting services to public and private entities.

It provides the basis for a career as a chartered accountant.

## **MANAGEMENT DELL'ECONOMIA SOCIALE**

The course trains professionals to take on managerial roles in social enterprises, cooperatives and non-profit organisations, integrating economic, legal and management skills to address the complexity of the third sector.

It also provides the basis for consulting and management support activities within these organisations.
