Annual organization

- The training is organized for 9 months (it is suspended on August, September and November). Each training period last 1 month and it is composed by practical activities at the University teaching dairy farm, didactic visits to external facilities and lessons.
- Each training shift includes a maximum number of 12 students (108 interns/year). Possible international students could be included in the shift in accordance with the Internship and Internationalization Office.

Each training period starts the first week day of the month with an organization meeting, on the platform Teams and following, at the University farm. Students will be informed by e-mail, by the end of the previous month. The meeting attendance is mandatory.

In this occasion, students will be informed by the calendar of the activities and on the organization of the training period.

All activities will be scheduled on a Monday-Friday 8-18.

Practical activities at the dairy farm

- Clinical visits
- o Milk, blood, feces and urine sampling
- o Penn State Partical Separator (PSPS) and RotAp methodics
- o Body Condition Score (BCS) and farm data management
- o Herd health data management and analysis

Activities will be held at the experimental-teaching dairy farm of the Department, located in via tolara di sopra 73, Ozzano Emilia (BO). <u>Dedicated clothing and safety boots must be worn during barn activities.</u> The latter are available to students at the locker room.

External visits and lessons

Visits to external facilities and frontal lessons will be scheduled each month. The specific program is communicated during the first meeting with the students on the first week-day of the month.
